

**2026 SNICKERS® NFL and Circle K Sweepstakes
Official Rules**

- **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES (AS DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The 2026 SNICKERS® NFL and Circle K Sweepstakes ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of date of entry. Employees, officers and directors of Mars Wrigley Confectionery US, LLC ("Sponsor"), Mars United Commerce, Realtime Media LLC ("Administrator"), Circle K Stores Inc., and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, the NFL Parties (defined as NFL Properties LLC, National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Enterprises LLC, NFL International LLC, NFL Productions LLC, (collectively the "NFL Entities"), and each of their respective affiliates, owners, subsidiaries, shareholders, officers, directors, agents, representatives and employees, both individually and collectively), and each of its their affiliates, franchisees, franchise employees, agencies, shareholders, officers, directors, members, successors, agents and assigns, (collectively, the "Sweepstakes Parties"), their respective IRS dependents, immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. In the event that a household, based on address, enters the Sweepstakes using more than five (5) unique email addresses, all of the Sweepstakes entries associated with that household (determined by Sponsor or Administrator at their sole discretion) will be disqualified. All applicable federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these "Official Rules" and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor's exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 12:00 p.m. (noon) Eastern Time ("ET") on September 2, 2026, and ends at 11:59 p.m. ET on November 3, 2026 (the "Sweepstakes Period"). The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** There are three (3) ways to enter the Sweepstakes:
 - A. **Online:** During the Sweepstakes Period, visit <https://SnickersNFL26.com> ("Website") and complete and submit an official entry form, including your full name, complete street address (no P.O. Boxes), email address, and phone number. You will receive one (1) entry into the Sweepstakes, subject to the limit below. On subsequent days, you may simply return to the Website and log in with your email address to receive an additional Sweepstakes entry, subject to the limit below.
 - B. **Snickers Purchase:** If you are a Circle K Inner Circle member, during the Sweepstakes Period purchase any Snickers product and enter your Inner Circle phone number on the LIFT screen at checkout to receive one (1) entry into the Sweepstakes, subject to the limit below. Note: potential

winners who enter via this method of entry will be notified via a one-time SMS message. Consent is not a condition of purchase. Please review the consent language presented on the LIFT screen at time of entry. See the Circle K Inner Circle program terms and conditions.

- C. In The Circle K App:** During the Sweepstakes Period, open the Circle K mobile app (the “App”) and follow the on-screen prompts to access the Snickers deal tile and click “Learn More”. Then, complete and submit the entry form including your full name, complete street address (no P.O. Boxes), email address, and phone number. You will receive one (1) entry into the Sweepstakes, subject to the limit below.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: One (1) entry per person per day, regardless of method of entry. A “day” is defined as a calendar day based on Eastern Time. Attempts made by the same individual to earn more than the stated number of entries by using multiple or false contact information, accounts or otherwise may result in disqualification. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means or using artificial intelligence (“AI”) in order to subvert the entry process are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, inaccurate, lost, late or misdirected, deceptive, or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor’s sole and absolute discretion. Those who do not follow all instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified, and all associated entries will be void. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the email address associated with such entry, provided that person is eligible and complies with the Official Rules. Any potential winner may be required to show proof of being the registered account holder. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible.

- 4. SWEEPSTAKES DRAWING:** On or about November 4, 2026, the Administrator will conduct a random drawing to select one (1) potential grand prize winner, five (5) potential first prize winners, ten (10) potential second prize winners, ten (10) potential third prize winners, fifty (50) potential fourth prize winners, and seventy-five (75) potential fifth prize winners from among all eligible entries received in accordance with these Official Rules.
- 5. ODDS:** Odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period.
- 6. WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via email using the information provided on the entry form (or, if the potential winner entered via LIFT screen, an SMS or phone call to the phone number associated with the entry) within two (2) business days after the drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, incomplete, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant’s email or other account to receive messages. Sweepstakes Parties are not responsible for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon sending a notification email. Any potential winner who entered via LIFT screen will be required to respond to Administrator’s notification within three (3) days to provide their mailing

address for prize fulfillment. As part of the winner verification process, the potential grand prize winner will be required to complete, sign, and return a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration") within three (3) days of Sponsor's time stamp of sending, as a condition of receiving a prize. The value of the grand prize awarded to be reported for tax purposes as required by law. The grand prize winner will be required to provide Sponsor with a valid social security number before the prize will be awarded for tax reporting purposes. An IRS Form 1099 (preceded by a W-9 Form) will be issued in the name of the grand prize winner for the actual value of the grand prize received. If any potential winner cannot be contacted within a reasonable time period or any notification is returned as undeliverable, if the potential grand prize winner fails or refuses to complete, sign, and return the Declaration within the required time period, and/or if any potential winner is deemed ineligible or noncompliant with these Official Rules or any of Sponsor's instructions, such potential winner will forfeit the prize and be disqualified, and an alternate winner will be selected in a random drawing from among all remaining eligible entries received. Up to three (3) alternate winners will be selected for a prize, after which the applicable prize will remain un-awarded. A potential winner becomes a "winner" only after verification of eligibility by Sponsor.

If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize available as set forth in these Official Rules, the winner(s) of the advertised number of prize(s) available may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.

One (1) Grand Prize: Each "Grand Prize" is "gas for a year" awarded as Three Thousand Five Hundred and 00/100 Dollars (\$3,500.00 USD) in the form of a check made payable to the Grand Prize winner. The approximate retail value ("ARV") of the Grand Prize is \$3,500.

Five (5) First Prizes: Each "First Prize" is a \$500 Circle K gift card. The ARV of each First Prize is \$500.

Ten (10) Second Prizes: Each "Second Prize" is an autographed NFL jersey, selected by Sponsor in its sole discretion. The ARV of each Second Prize is \$250.

Ten (10) Third Prizes: Each "Third Prize" is an autographed NFL mini helmet, selected by Sponsor in its sole discretion. The ARV of each Third Prize is \$150.

Fifty (50) Fourth Prizes: Each "Fourth Prize" is a \$50 Circle K gift card. The ARV of each Fourth Prize is \$50.

Seventy-Five (75) Fifth Prizes: Each "Fifth Prize" is a \$25 Circle K gift card. The ARV of each Fifth Prize is \$25.

Total ARV of all prizes available in the Sweepstakes is \$14,375.

Gift cards will not be replaced if lost, stolen, or damaged. Subject to issuer's terms and conditions.

Any depiction of a prize element in any marketing is for illustrative purposes only, and actual prize details/appearance may vary. Each winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether it, in whole or in part, is used. The ARV of the prizes is based on available information provided to Sponsor as of the time these Official Rules are printed and may fluctuate. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated, or stolen prize or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of the prize. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.

11. RELEASES: All entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sweepstakes Parties and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's registration material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.

INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

- 13. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of New Jersey, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of New Jersey. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of New Jersey. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
- 14. ENTRY INFORMATION AND SWEEPSTAKES COMMUNICATIONS:** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address, and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations, and rules. In the event of any discrepancy between the Sponsor's Privacy Policy and these Official Rules, these Official Rules shall control and govern.
- 15. MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
